Grants and Awards In 2015, through its grants to the AANI's Clinical Research Training Fellowship Program, the Foundation enabled the AANI to identify and further the research of 20 of the best and the brightest early career clinical neuroscientists working on innovative research to treat, prevent or cure a wide variety of diseases of the brain and nervous system. (Historically, the Foundation and the AANI operated under the same management. Effective in 2015 the Foundation established independent management.) AANI continues to support ABF through operating support grants, whereas the Foundation raises money to fund research on brain disease.

Public Education The American Brain Foundation (ABF) participated in the Brain Health Fair held at the 2015 American Academy of Neurology's Annual Meeting in Washington DC. This free, daylong family event connected nearly 12,000 patients, families, and caregivers affected by a neurologic disorder with important resources to win the battle against brain disease. People attended free classes to learn from some of the best and brightest neurologists in the world about the latest research advances in Alzheimer's, autism, brain injury, epilepsy, headache, multiple sclerosis, Parkinson's, sleep disorders, stroke, and other types of brain disease. The Exhibit Hall offered fun activities for kids and teens, and giveaways. The ABF provided a grant to PBS in support of the six-part, nationally televised series, "The Brain with David Eagleman".


